## Local Funding Entities Distribute \$13.3 Million to Area Nonprofits 2021 Philanthropic Data Report

elaplaine Foundation was among the eleven philanthropic organizations that once again pooled its 2021 funding data for the Shared Philanthropic Data and *Gaps Analysis: 2021 Report.* The goal of the report is to gain greater insight into the purposes, programs, services, and projects receiving grant funding in Frederick County. Other participating funders included the Ausherman Family Foundation, The Community Foundation of Frederick Co., Frederick County Government Community Partnership Grants, Helen J. Sirini Foundation, United Way of Frederick Co., William E. Cross Foundation, Loats Foundation, Kahlert Foundation, Will Group Foundation, and the Women's Giving Circle of Frederick Co.

Key findings generated in the Executive Summary included the following:

- Overall, funders disbursed almost \$13.3 million in 2021. This amount was some \$500,000 less than the previous year, when COVID-19 funding peaked.
- The majority of spending (84%) was directed towards ongoing projects, while 16% targeted new initiatives.

- When divided by category, most funding was spent on Human Needs (48.41%), followed by Education (22.24%), and Arts and Culture (8.97%).
- Approximately 53% of funding supported direct programs and services, while 35% of funding was allocated to general operations, and 9% was intended for capacity building of organizations.

Other findings indicated a preference among funders to support larger, more established organizations. In many cases, larger, established nonprofits may have the infrastructure and expertise necessary to effect broader impact. "Delaplaine Foundation consistently seeks to achieve the most substantial impact through grant funding," said Marlene Young. "Within each grant cycle our Board seeks to fund both impactful, established nonprofit organizations as well as pilot programs or first-time grant applicants whose requests expose and shed light on an unmet need in Frederick County."

## TAP Spotlights Vulnerabilities Through Art Therapy Programs

Transformative Arts Project (TAP), one of Frederick County's newer nonprofit organizations, calls on a wide array of arts experiences in its goal of transforming and empowering the lives of those experiencing disabilities, homelessness, addiction, mental illness, or other vulnerable circumstances. TAP was founded during the pandemic by Laura Sherwood who serves as the executive director. TAP's programming is intended to amplify the successes and social challenges within communities and make them known to local residents for greater understanding and for the potential of positive change.

One example of TAP programming is the Photovoice Empowerment Project, which received support from Delaplaine Foundation during the most recent grant cycle. Photovoice is intended to engage and empower community members' voices and lived experiences through artistry. Working in partnership with the Housing Authority of The City of Frederick, eight



young women were given cameras to capture images that addressed the following questions: "what does your community need" and "where does your community succeed." The resulting images portrayed the needs and strengths of individuals and the local community, which were exhibited at the 2022 Frederick Festival of the Arts.


Other participants included a man born with multiple disabilities who photographed a cracked pipe next to a building. He responded when asked what the picture meant to him. "Just because something looks broken doesn't mean it is. People like me who have disabilities learn and do things differently, but that doesn't mean we are broken or incapable of doing things for ourselves. We need to be given a chance to learn to do things our own way, instead of others always thinking they know what is best for us or that our way is the wrong way!" These are the pivotal moments sought by TAP, when people learn to articulate their experiences and communicate through artistic images.

## Second Chances Garage Supports Local Residents With Donated Cars and Low Cost Auto Repairs

Second Chances Garage, Inc. (SCG) is a nonprofit organization with a mission of empowering families and individuals to achieve economic and personal independence through car ownership. Founded by Rick and Cindy Trawick in 2010, the downtown Frederick, MD-based SCG serves the local community through a variety of programs, one of which is offering low-cost car repairs for families with limited incomes. Individuals who receive public assistance and meet income requirements can qualify for car repairs that encompass brakes, exhaust, cooling, suspension, body, and electrical issues.

SCG also offers the Low Cost Vehicle program, which makes cars available to worthy individuals on the path to self-sufficiency. Delaplaine Foundation has partnered with SCG in funding the Low

Cost Vehicle program. Donated cars are carefully examined, repaired, inspected, cleaned, and then awarded to people who were previously dependent on others for transportation. Currently employed individuals who have completed



programs offered through partnering agencies are eligible to receive the cars. The benefits of car ownership are numerous.

In addition to making recipients eligible for car dependent jobs, automobile ownership makes immediate transportation available for educational, health care, and other family needs. These new opportunities lead to stronger futures for individuals, which ultimately impact the community at large.

SCG has a current critical need for donated vehicles. If you own a car that is not being used, SGC will thankfully accept it, regardless of its condition or mileage. As SGC is a qualified nonprofit, tax benefits may be available to those who donate a car.

You can also support SCG by participating in the 9th Annual Second Chances Garage Road Rally on October 22. Participants, driving their own vehicles, will use a booklet of clues to compete in a scavenger hunt. This scenic rally is designed so that drivers can enjoy beautiful fall foliage as they wind through the picturesque roadways of Frederick County. The event includes lunch and prizes.
