#### Michele Corr Named Executive Director of Delaplaine Foundation

Foundation Restructures
With New Leadership Position
In Response To Growing
Organizational Needs

The Board of the Trustees of Delaplaine Foundation is pleased to announce that Michele P. Corr has accepted the newly-created position of Executive Director at the Foundation. The Frederickbased philanthropic organization established in 2001 is dedicated to enriching the quality of life in Frederick County and beyond through financial support of nonprofit organizations whose missions align with that of the Foundation. In the role of Executive Director, Corr will oversee the Foundation's daily operations. Marlene Young will continue to serve as president and CEO of the organization until her retirement on June 30, 2025 at which time she has agreed to continue to serve as President of the Foundation's Board of Trustees.

"In recent years, the work of the Foundation has grown exponentially, requiring internal reorganization," explains Young. "We're thrilled that Michele has accepted the position of Executive Director. Her professional experience and extensive knowledge of the community will enable her to lead the organization as it continues to grow."

A native of Frederick, MD, Corr will leave her post as Executive Director of Friends of Catholic Education, Inc., (FOCE) to



assume her new position at Delaplaine Foundation on January 6, 2025.

"I have followed the impactful work of Delaplaine Foundation over the years and always viewed Marlene Young as the gold standard when it comes to nonprofit leadership," said Corr, who has served as Executive Director at FOCE since 2016. "I am so excited to have the opportunity to collaborate with the staff and board of the foundation to advance its mission. I have profound respect and admiration for George Delaplaine, Jr., his family and the enduring legacy they have built."

FOCE is dedicated to providing block grants and scholarships to students who wish to attend one of Frederick County's five Catholic schools. In the 2024-2025 school year FOCE awarded block grants and scholarships to 57 students totaling \$112,250. This figure contributes to the organization's overall award total of over \$5 million since its founding in 1989. "I've thoroughly loved my work and will continue to enjoy the many wonderful associations I've made at Friends," said Corr, who will remain on the FOCE Board of Trustees.

## Nonprofit Funds Opportunities for People with Special Needs

The Monocacy Foundation (TMF) is a nonprofit organization whose mission is to provide opportunities to people in Frederick County who have been diagnosed with intellectual or developmental disabilities.


The organization arose out of a tragic situation experienced by Millie Diggs, a woman with special needs living in a community home, who was known for her love of dancing, singing, and her favorite musician, Prince. In addition to receiving Social Security benefits, Millie worked at Goodwill. In 1995, Millie decided that she wanted to take a trip to Disney World and began saving paychecks in order to fund her trip. Just as she was about to meet her financial goal, Millie was informed by Social Security Administration that she had too much money in her bank account, and was no longer able to receive Social Security benefits.

Millie never had the chance to take her dream vacation to Disney World, as she passed away unexpectedly. This heartbreaking, but very common problem of the inability to afford the 'extras' in life is one that children and young adults diagnosed with disabilities often face.

TMF was founded in 1995 with a goal of providing opportunities and experiences to those individuals who are unable to save their own money without risking loss of critical benefits. As of 2024 TMF has awarded over \$600,000 worth of grant funding to individuals and to local nonprofits. Awards have made for therapy visits, summer camps, therapeutic horseback riding, dental and vision care, specialized college classes, sensory items, art supplies, music classes and instruments, and so much more. While some of these experiences and services might be considered nonessential, they can be vital to the recipient, helping them to have a meaningful and happy life. These awards can also relieve some of the financial pressure felt by families of the recipients, who often struggle to pay for medical bills and other large expenses that come with raising a child with special needs.

## Delaplaine Foundation Awards \$2.95m to Nonprofits in 2024



For the 2024 grant cycle, Delaplaine Foundation awarded a record amount of grant funding to nonprofits in Frederick County and surrounding areas. After receiving 162 grant applications, the Delaplaine Foundation Board of Trustees awarded grants totaling \$2,950,400. This amount includes \$300,000 of discretionary funding. In total, over 170 nonprofit organizations received a grant or grant installment, including thirteen first-time grantees. Approximately 90% of grant awards were given to programs and projects impacting Frederick County, and 41% of funding was directed towards Human Services.

Romeo was brought to the Foundation by February Star Sanctuary, a familyrun nonprofit with a mission to rescue, rehabilitate, rehome and provide refuge for horses in need. Interactions with horses can be highly beneficial, and FSS has developed equine-therapy programming to benefit youth, people with developmental disabilities, and residents of nursing home facilities. These programs promote important lifelong values such as empathy, patience and companionship, reduce social anxiety and teach responsibility, as well as providing participants with exciting and memorable experiences.

Delaplaine Foundation has supported February Star Sanctuary since 2022. In the 2024 grant cycle, FSS received a \$7,500 grant for the Horses Helping Humans of All Ages program.
